CEP offers two certifications:

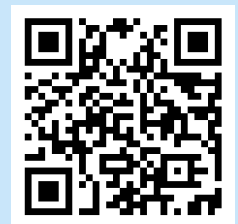
- Certified Professional in Energy (CPE)
